THIS IS TO CENTIFY that we, the undersigned, do hereby associate ourselves into a corporation under and by virtue of the provisions of the laws of the State of North Carolina, as contained if Chapter 55A of the General Statutes, and do severally agree to become members thereof; and to that end do hereby execute this certificate of incorporation in manner and form as follows:

ITEM ONE

The name of the corporation shall be THE NEW HOPE IMPROV WENT ASSOCIATION, INC.

ITSM TWO

The period of duration shall be perpetual.

ITEM THREE

The purposes for which this corporation is formed are as follows:

To promote the common good of the residents and property owners of the New Hope Creak and its watershed, to promote the health and welfare of its members end the members of the community within the watershed of New Hope Creek, AND WITH THE FURTHER purpose that said corporation confine its activities to non-profit matters and dealings.

### ITEM FOUR

This corporation shall have no capital stock. Porticipation in its affairs shall be by membership therein subject to the following rules and regulations:

- (a) Byglaws governing the admission of members, the amount of initiation fee and periodic dues, the rules and regulations to be observed, the qualifications for voting, the resignation or expulsion of members, the election, powers and duties of officers and a general governing body, and all other matters and things usually and legally contained in corporate by-laws may from time to time be adopted, and repealed by the affirmative vote of a majority of all members entitled to vote under the by-laws then existing.
  - (b) At all meetings of the membership, each member entitled to

who is entitled to vote for himself at such meeting, and mo member shall at any meeting cast the vote of more than one proxy.

- (c) No dividends, except upon the dissolution of the corporation, shall be declared or paid to the members.
- (d) No member who has died, resigned, or been expelled shall thereafter have any interest in or claim upon the property or assets of the corporation.
